This Service Level Agreement ("SLA") is entered at Barnala, Punjab, India on this 18th day of April 2022.

BETWEEN

Karo Sambhav Private Limited, a company incorporated under the laws of India and whose registered office is situated at 408 & 409, 4th Floor, Suncity Business Tower, Golf Course Road, Suncity, Sector 54, Gurugram, Haryana 122002, and shall mean to include its subsidiaries and affiliates (herein after referred to as the "Karo Sambhav").

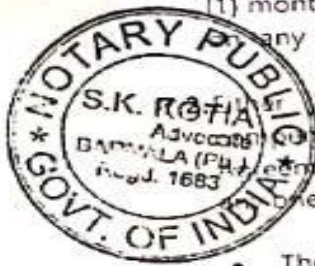
6.3. Each of the parties undertakes to the other to take all such steps as shall from time to time be necessary to ensure the compliance with the provisions of this clause 4 by its officers, employees and agents.

6.4. Neither Party shall make any publicity on the contents of this SLA by press release or reference to this SLA without the consent of the other Party.

6.5. Affiliates of a Party hereto engaged in the performance of this SLA shall not be deemed to be third parties for purposes of this Clause 4 on condition that disclosure of Information occurs on a need to know basis only and that the respective Party ensures full compliance by such affiliates of all the provisions of this Clause 4.

7. Termination

7.1. Karo Sambhav and SDC shall have the right to terminate this SLA for convenience and without liability upon providing each other no less than one (1) month prior written notice. However, in the event the parties are working on any Assignment that Assignment shall continue till it is completed.



7.2. The Non-Defaulting Party (the "Non-Defaulting Party") may, without penalty or compensation to the other Party (the "Defaulting Party"), terminate this Assignment at any time, effective upon written notice to the Defaulting Party in any one of the following events:

- The Defaulting Party materially breaches this SLA, and such breach remains un-remedied for thirty (30) days following written notice of breach by the Non-Defaulting Party; or
- The Defaulting Party fails to meet its performance obligations under the SLA and Assignment, and such obligation remains unmet for thirty (30) days following the Non-Defaulting Party's written notice of non-performance; or
- The Defaulting Party is adjudged or becomes bankrupt or insolvent, is unable to pay its debts as they become due, or makes an assignment for the benefit of its creditors; or
- The Defaulting Party voluntarily or involuntarily undertakes to dissolve or wind up its affairs.

7.3. The provisions of any Clauses of this SLA that by nature will remain in effect after termination, shall survive any termination of the Agreement.



Intellectual property shall mean all forms of intellectual property rights subsisting under any law or equity and all analogous rights subsisting under the laws of all jurisdictions and shall include any product or process of the human intellect whether register-able as patents, trademarks, copyrights, designs or otherwise such as an invention, or derivative work of the same expression or literary creation, unique name, trade secrets, business method, database, industrial process, computer program, source code, process, presentation, etc.

SDC shall at all times recognize the validity of the Trademark and ownership of the Trademark of Karo Sambhav; with the sole presenting sponsor and will not at any time put in issue the validity or ownership of the Trademark of Karo Sambhav.



5. Public Relations

Subject to clause 3(4), Karo Sambhav and SDC shall leverage the programme(s)/projects agreed under this SLA for furthering the cause of awareness towards WEEE recycling via Public Relations in each party's newsletters, websites etc.

6. Confidentiality

6.1. The Parties acknowledge a duty from the date of signing this SLA and after the termination or expiry of this SLA not to disclose without the other's prior written permission any information either concerning the other's business carried on or proposed or intended to be carried on, its business plans, customers or associates.

6.2. The restrictions in clause 4(1) shall not prevent the disclosure of information where such disclosure or use of confidential information is necessary for the proper performance of the party's duties under this agreement or disclosure of such information is required by law or where such information has come into the public domain otherwise than through unauthorized disclosure.

2.3. Provide awareness material for dissemination to the employees and staff of SDC in organizing awareness drives.

SDC

SDC to provide all support required for meeting the objectives mentioned above. This support shall include but will not be limited to:

- 2.4. Designate two persons who shall be named under this SLA and who will be responsible for managing the E-waste generated.
 - 2.5. Organise and coordinate awareness drives within their premises.
 - 2.6. Disseminate awareness material on responsible recycling of E-waste provided by Karo Sambhav.
 - 2.7. Ensure that the employees are aware of the E-waste items which are to be dropped at the Collection Center(s) in nearest collection center (in case the weight is less than 100 Kgs and the collection center is available in your city) as per the list shared by Karo Sambhav.
 - 2.8. Make necessary arrangements for transportation of e-waste below 100 Kgs per trip or the material will be given to Karo Sambhav for free of cost.
- Conduct Awareness programme on e-waste management at the all the secondary capuses/colleges followed by collection drive for all their employees in a financial year.



3. Costs and Terms of Payments

Parties agree to collaborate on the below mentioned terms of payments:

- 3.1. Collection of E-waste from SDC Unit(s) in Punjab state. (a minimum weight of 100 Kg) - Karo Sambhav to pay SDC for the E-waste collected as per the quotation shared by Karo Sambhav before each pickup or in case the e-waste is less than 100 kg per trip then the e-waste collected by the Karo Sambhav will be given free of cost from the SDC.
- 3.2. Payment will be made to SDC by Karo Sambhav within 7 business days through RTGS/NEFT after SDC raises an invoice.
- 3.3. Awareness material - Designed collaterals/ awareness material to be shared by Karo Sambhav with SDC. Awareness materials provided by the Karo Sambhav for the programme are purely for the purpose of generating awareness among your employees of SDC. These materials are the sole property of Karo Sambhav and cannot be tampered/modified with. Karo Sambhav does not encourage the use of collaterals for uploading on social media without prior notice or to be distributed amongst any third-party individual, organisation or authority.

2. Role and Responsibilities




