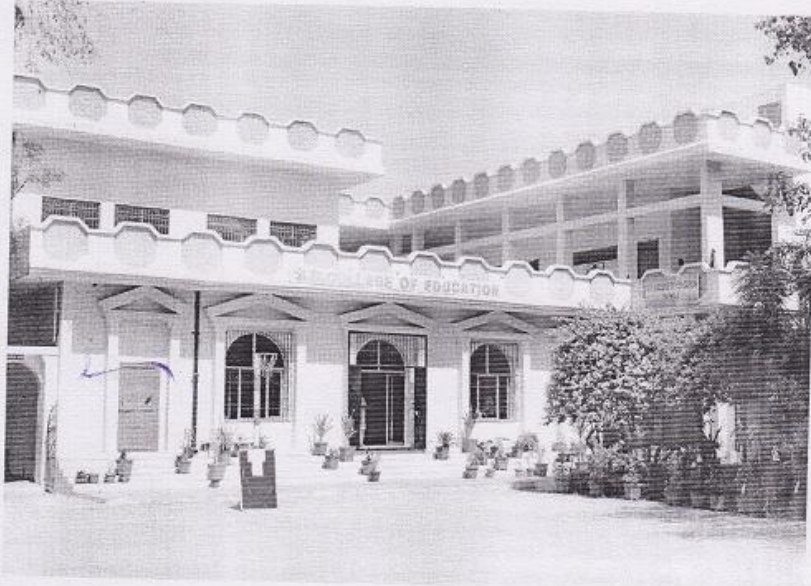

CONSTITUTION OF S.D.COLLEGE EDUCATIONAL SOCIETY BARNALA.

NAME

The Name of the society is S.D.College Educational Society, Barnala. The registered office of the society shall be located at S.D.College, Barnala.

AIMS AND OBJECTS

The aims and objects of the Society are:-

- a. To impart higher education to the students without any distinction of caste and creed.
- b. To arrange, if need be, education at primary and school level also in the schools established by the society.
- c. To provide means for imparting technical and vocational education to students so as to brighten their future prospectus.
- d. To provide facilities for imparting sound moral and religious education based on Sanatanist scriptures.

MEMBERSHIP

- a. Life Members: Those who pay Rs.1000/- or more at a time shall be life members of the society.
- b. Ordinary Members: Any person subscribing to Sanatanist ideology can become an ordinary member of the society by paying Rs.1000/- per annum.

A person can be removed from the membership of the society by a majority vote if it is found that his continuance as member is detrimental to the interest of the society.

MANAGING COMMITTEE

There will be Managing Committee to run the affairs of the society and institutions under its charge.

(1)- COMPOSITION

- a. The Managing Committee will not consist of more than 25 and less than 17 members.
- b. The Principal of the College and two staff representatives will be members of the Managing Committee in addition. They will have no voting rights in the Election of office bearers of the society.

A member of the Managing Committee can be removed by two-third majority, in case the said member is found working against the interest and aims and objects of the society.

11. FUNCTIONS OF MANAGING COMMITTEE

The Managing Committee of the Society shall

1. take proper steps for the implementation of the aims and objects of the society;
2. appoint, if need be, sub-committees for the efficient discharge of its various functions;
3. Manage and control the institutions started by the society;
4. Manage the movable and immovable property of the Institutions established by the society in any or all of the following purposes:-
 - a. Land & immovable property
 - b. Fixed and Time Deposits.

WHEREAS, in exercise of the powers conferred by Sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.



WHEREAS, the recognition has been granted to the institutions mentioned in para 5 below for the duration of two years against their name.

AND WHEREAS, the said institutions by affidavit have consented to come under New Regulations and have sought for the number of units in B.Ed./M.Ed. as mentioned in para 5 below against their name, which may include additional facilities.

- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. This order shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case and in respect of Section 17/complaint cases etc. as decided by the Northern Regional Committee.

5.
